The Health Care Professions Licensing Board (HCPLB) is to provide services and initiatives that promote patient safety, quality of health care and regulatory best practices. Established by Public Law 15-105



AGENCY OVERVIEW

The Board of Professional Licensing (BPL) and the Health Care Professions Licensing Board (HCPLB) are key regulatory agencies committed to protecting public health, safety, and welfare in the CNMI.

BPL and HCPLB boards ensure that health care professionals are properly qualified and competent to practice. The Board consists of five members with one vacancy since January 2025 and is supported by an Executive Director and an Administrative Assistant.

Together, BPL and HCPLB regulate more than 44 professions, with limited enforcement activities—such as site visits and investigations – remaining a concern. Although few complaints are received, regular monitoring is essential to prevent issues. The investigator position has remained unfunded for the past three years due to budget constraints. Currently, the Attorney General's Office Investigation Division helps in investigating formal complaints.

In FY2025, HCPLB focused on updating the following key regulations to address funding needs, align regulations with federal standards, and strengthen professional guidelines:

- Limited Licensure for Foreign Graduates
- Increased License Fees and Services
- Medical Laboratory Technician
- Occupational Therapist

These updates reinforce the boards' commitment to maintaining high standards in health care practice across the CNMI.

Starting June 2025, BPL and HCPLB launched its online licensure applications,

renewals, and payments from anywhere. Localgov, under the umbrella of Azavar Government Solutions, a U.S. company, manages an online platform for BPL and HCPLB to facilitate licensure. At the latest, BPL and HCPLB have uploaded 100 percent of their active licenses to Localgov, and new applications are gradually moving online. Localgov provides 24/7 services for those who need help logging in and offers hope for automating client information, licensing data, and online payments.

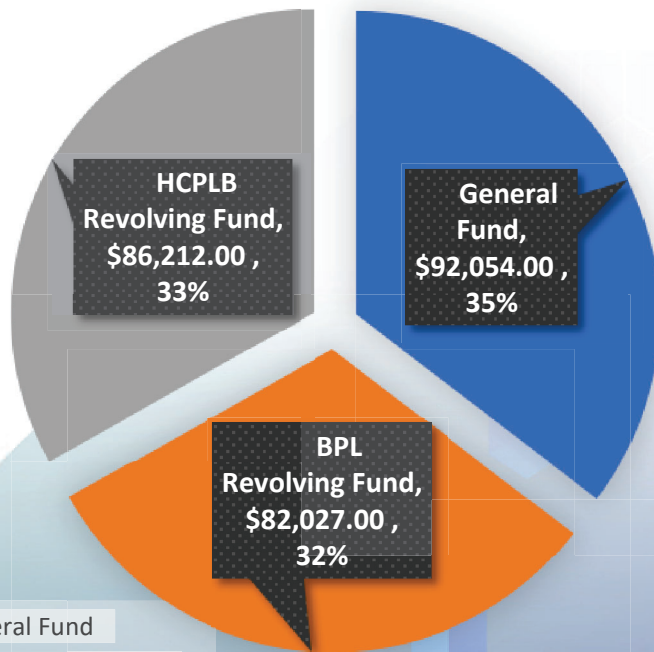

KEY INITIATIVES

Moving Forward.....

Although the BPL and HCPLB have made significant progress in improving the licensure process, much work remains. Since the Secretary of Finance approved their collaboration with Localgov in 2024, the new integrated and automated software system has simplified the online submission of licensure applications.

One of the significant challenges both boards continue to face is the need for on-site inspections to ensure compliance and respond to complaints. Due to ongoing budget constraints, the short-term solution is to issue a limited-term professional services contract to fill the gap left by the absence of a full-time investigator.

Moving forward, BPL and HCPLB will focus on the following priorities:

- Completing and fine-tuning the Localgov data management system to streamline applications, renewals, and workflows.*
- Conducting outreach to schools and organizations.*
- Continuing to work with OMB to secure funding for an in-house enforcement officer.*
- Advancing the vision of safe practice environments and exploring new pathways for health care practice.*

Both BPL and HCPLB recognize the progress made and express appreciation for the continued support of national partners and stakeholders.
