COMMONWEALTH LOTTERY COMMISSION

WHO WE ARE

The Commonwealth Lottery Commission (CLC), is tasked to supervise, organize, and operate a public lottery in the Commonwealth. The public lottery shall be administered and operated to produce the maximum amount of net revenues for the Commonwealth consonant with the general welfare of the people. (Source PL 3-60, § 1; subsection (d) added by PL 18-20 § 2 (October 7, 2013) PL 3-60 took effect June 3, 1983).

Executive Order 2025-002 - Issued by Governor Arnold I. Palacios, was passed through the House and Senate transferring the authority for supervision of casino gaming from the Commonwealth Casino Commission (CCC) to the Commonwealth Lottery Commission (CLC)

PL 18-38 as amended by Public Law 18-43 then granted CNMI Lottery Commission to review applications.

PL 18-20 allowed video terminals to be part of the operation of a public lottery.

PL19-24 Section 10 (h) The power to issue Casino Licenses lies with the Commonwealth Lottery Commission.

EXPENSE

Since all public hearings and meetings were performed during normal government hours and on government premises therefore the CLC has had no expenses.

CHALLENGES

The Commonwealth Lottery Commission (CLC) has faced a unique set of challenges this year, primarily stemming from a major organizational pivot and the first year of an entirely new board of commissioners working together. This new, collaborative environment has been foundational to a comprehensive effort focused on revising policy and reorganizing the commission's operational structure. This internal work is crucial for streamlining processes and enhancing efficiency as the gaming industry in the Commonwealth of the Northern Mariana Islands (CNMI) emerges.

Adding to this complex environment is the recent transition outlined in Executive Order 2025-002, which transfers the authority of the Commonwealth Casino Commission to the Commonwealth Lottery Commission. Anticipating and preparing for the changes that come with this transfer including the assumption of new regulatory oversight responsibilities is a significant undertaking.

Furthermore, a regulatory challenge will always be attracting and vetting qualified applicants for gaming licenses. This effort is vital to establishing a sustainable and responsible gaming environment. The commission must ensure this process remains robustly transparent, competitive, and in strict alignment with regulatory standards to foster an industry that benefits the Commonwealth as a whole. The successful policy revisions and reorganization efforts undertaken by the new commission this year are explicitly designed to meet these complex demands head-on.

OUTLOOK

The Commonwealth Lottery Commission will continue with its functions in collaboration with the Administration, the Attorney General's office, and the public in the best interest of the Commonwealth.
